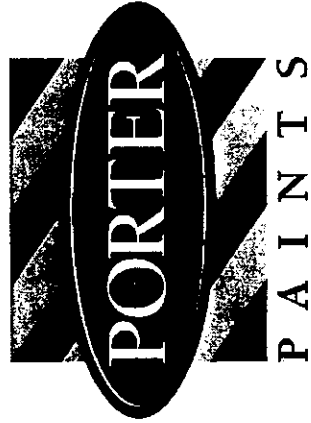

Rules & Regulations

- RULE DECISIONS:** The interpretation of these rules shall be left exclusively to the Tournament Director. The decision of the Director shall be final.
- SAFETY:** Safe boating conduct must be observed at all times by all tournament participants. Safety vest should be secured properly while combustible engine is running. There will be no alcoholic beverages permitted. Any presence of alcoholic beverages will necessitate immediate disqualification.
- SPORTSMANSHIP:** Courtesy, safety, and conservation is expected from each participant. Any infraction of these fundamental sporting principles may be deemed cause for disqualification.
- TACKLE & EQUIPMENT:** Only artificial lures may be used. NO 'LIVE' or 'PREPARED' BAIT will be permitted, with the exception of pork or pork-type strips, rinds, etc. only casting, spinning, or spin-casting reels and rods may be used. maximum rod length is 8 feet in length.
- SCORING:** Scoring will be determined by total weight. The Tournament winners will be determined by the total weight accumulated during tournament fishing. Legal tournament fish include: Large Mouth Black Bass, Kentucky-Spotted Bass, or Small Mouth Bass. A total of 5 fish may be weighed in per boat. At no time shall any contestant have more than the state limit. Periodic checks by the officials. Both state and tournament, will be made, and any contestant having more than the limit in his possession shall have his fish culled to the limit by the official. The largest fish will be culled first. Contestant must present his own catch to weigh in station. After fish have been handed to weigh-in officials, no person, except officials, shall touch said fish. A bass will not be counted or weighed that is less than 15 inches in length. As a penalty any undersized fish will be thrown out, plus a 16 ounce penalty assessed. Any fish that appears to be mangled in any way will be measured and credited only at the discretion of the Tournament Director. All fish become the property of YCBC. Live fish will be returned to the water. Dead fish 4 ozs. will be deducted from total weight.
- LATE PENALTY:** Contestants who are not in the official docking area on time shall be penalized 1 lb. total weight for each one (1) minute he is late. A contestant signing in at the dock more than 10 minutes late is automatically disqualified.
- ILLEGALITIES:** Staking out fish, lead loading, or otherwise unsportsmanlike procurement prohibited. In such cases, both contestants will be disqualified from this and all future tournaments.
- PROTEST:** Anyone wishing to protest the score or any broken rule(s) shall do so before any awards are made.
- REGISTRATION:** Sign-in will start at 4:30 a.m. at Birdsong. All boats should be in the water by 5:45 a.m.
- TOURNAMENT HOURS:** 6:00 a.m. to 3:00 p.m. All contestants will have equal fishing time, however, staggered takeoffs and returns may be required.

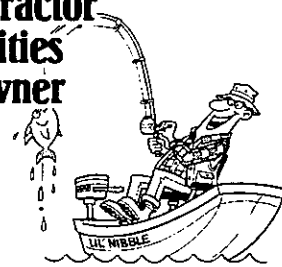

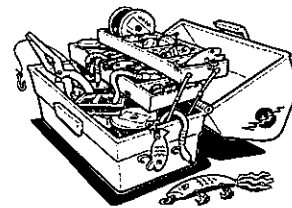

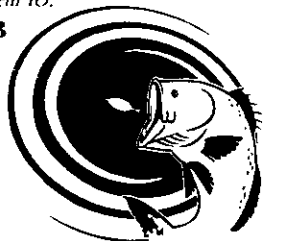
